Re: Unconstitutional Religious Promotion

Dear Superintendent Derryberry:

I am writing on behalf of the Freedom From Religion Foundation (FFRF) regarding a constitutional violation occurring in Hinton Public Schools. FFRF is a national nonprofit organization with more than 33,000 members across the country, including members in Oklahoma. Our purposes are to protect the constitutional principle of separation between state and church, and to educate the public on matters relating to nontheism.

It is our understanding that Grant Potter, Hinton High School football coach, recently posted a religious message on the team's Facebook page. In the post, he explains that "in the Hinton Football Program we want to live by a simple Biblical principle 'Love your neighbor as yourself." He continues, "We don't all have the same life experiences but the Bible doesn't call us to love only those like us. It calls us to love everyone." Please see the attached screenshot.

While we agree with the sentiments of unity and togetherness that the coach promotes in his post, it is a violation of the Establishment Clause for teachers and coaches to endorse a religious message to students. This "[s]chool sponsorship of a religious message is impermissible because it sends the ancillary message to members of the audience who are nonadherents 'that they are outsiders, not full members of the political community and accompanying message to adherents that they are insiders, favored members of the political community." *Santa Fe Indep. Sch. Dist. v. Doe*, 530 U.S. 290, 309-10 (2000) (quoting *Lynch v. Donnelly*, 465 U.S. at 668) (O'Connor, J., concurring). Coach Potter's promotion of religion over non-religion undeniably turns any non-believing student, staff member, or fan into an outsider. Non-religious Americans make up the fastest growing segment of the U.S. population by religious identification – 35 percent of Americans are non-Christians,¹ and

this includes the more than one in four Americans who now identify as religiously unaffiliated. $^{\rm 2}$

The District has an obligation under the law to make certain that "subsidized teachers do not inculcate religion." *Lemon v. Kurtzman*, 403 U.S. 602, 619 (1971). Certainly, "a school can direct a teacher to 'refrain from expressions of religious viewpoints in the classroom and like settings." *Helland v. S. Bend Comm. Sch. Corp.*, 93 F.3d 327 (7th Cir. 1993) (quoting *Bishop v. Arnov*, 926 F.2d 1066, 1077 (11th Cir. 1991)). The Supreme Court has recognized that "[f]amilies entrust public schools with the education of their children, but condition their trust on the understanding that the classroom will not purposely be used to advance religious views that may conflict with the private beliefs of the student and his or her family." *Edwards v. Aguillard*, 482 U.S. 578, 584 (1987).

Federal courts have ruled public school coaches and athletic personnel must not promote religion. See, e.g., *Borden v. Sch. Dist. of the Township of East Brunswick*, 523 F.3d 153 (3rd Cir. 2008)(declaring the coach's organization, participation and leading of prayers before football games unconstitutional); *Doe v. Duncanville Indep. Sch. Dist.*, 70 F.3d 402 (5th Cir. 1995) (declaring basketball coach's participation in student prayer circles an unconstitutional endorsement of religion). Asking students in the Hinton Football Program to live by biblical principles violates this constitutional principle.

We ask that Hinton Public Schools commence an investigation into the complaint alleged and take immediate action to ensure that religion is no longer being promoted in any District athletic program. This Facebook post must also be removed. Please inform us in writing of the steps the District takes to remedy this violation of the First Amendment.
