MOTION FOR CONTINUANCE

The Plaintiffs respectfully move the Court for a continuance of the motion hearing presently scheduled for September 15, 2008, at 1:30 p.m. The Defendants have moved to dismiss on grounds of mootness, although no formal action has been taken by the City of Green Bay since adopting a moratorium on religious displays on city property.

A recent report by the Associated Press dated September 6, 2008, however, reports

that the City of Green Bay could have a formal policy in place for Christmas displays in the

near future. The news report indicates that Mayor Jim Schmitt "recently met with clergy

members to get their ideas on a city policy. They agreed that the City should stick with

secular decorations and leave the religious displays to area churches and synagogues."(See

he hopes to present a policy to the city council in October."

The Plaintiffs request a continuance of the presently scheduled argument, which may

be affected by what, if any, policy the City Council adopts in October. This development

presumably will bear upon the arguments of the parties and the decision of the court, but in a

way that can not be predicted at this time.

In the interest of judicial efficiency and economy, therefore, the Plaintiffs make this

Motion for Continuance of the scheduled motion hearing.
