**DECLARATION OF DANIEL KOSTER IN SUPPORT OF PLAINTIFFS' MOTION
FOR SUMMARY JUDGMENT FOR INJUNCTIVE, DECLARATORY,
AND OTHER RELIEF**

I, Daniel Koster, declare and state as follows:

1. I am over the age of eighteen. I have personal knowledge of, and am competent to testify to, the matters herein.
2. I am a former student of Wekiva High School, which is a school within Orange County Public Schools. I was a student there from 2009-2013.
3. World Changers of Florida ("World Changers") distributed New International Version Bibles to students at my school on January 16, 2013.
4. I received two copies of NIV Bibles from World Changers on January 16, 2013, including a version published by Biblica, Inc.
5. The NIV Bible by Biblica, Inc. that I received from World Changers contained content in addition to the text of the Bible. Exhibit 1 is a true and correct copy of additional pages that were included with the Bible I received.

6. In addition, the NIV Bible by Biblica, Inc. that I received included an insert seeking students to join the Fellowship of Christian Athletes. Exhibit 2 is a true and correct copy of the solicitation to join the Fellowship of Christian Athletes that was included in the New International Version Bible I received.
7. I received the Bibles from a table that was staffed by an adult who talked with students. I took photographs of the distribution table and Bibles. Exhibits 3 and 4 are true and correct photographs of the distribution table and Bibles that were distributed. I also observed that a second table was used to distribute similar materials.
8. The copyright page of the NIV Bible by Biblica, Inc. that I received contained a website, email, phone, mail, and other contact information, and a solicitation that said, "Call us today or visit us online to receive a free catalog featuring hundreds of biblical resources priced for ministry." It also said, "Biblica provides God's Word to people through translation, publishing and Bible engagement in Africa, Asia Pacific, Europe, Latin America, Middle East, and North America. Through its worldwide reach, Biblica engages people with God's Word so that their lives are transformed through a relationship with Jesus Christ."
9. Page ix of the NIV Bible by Biblica, Inc. that I received said, "For more help in understanding the Bible and finding your place in its story, go to Biblica.com/LivingTheScript."
10. Page 878 of the NIV Bible by Biblica, Inc. that I received said:
"Biblica.com/LivingTheScript. We hope this resource will help you make deeper and deeper connections with the Bible. The process of being transformed by God's Word never stops. Of course, we can't give you all the help you need at a website. We also

hope you'll seek out other people to read and discuss the Bible with, so you can engage the Bible together. The Bible was meant to be experienced in community. This is key for discovering what it means to live the story today. But perhaps the most crucial thing of all is for God himself to guide you into good understanding. We pray that you will stop and ask him to do just that. In the end, it is his drama that we're all invited into."
