- 2.) Any records (including emails, brochures, letters, etc.) received or sent by Bolivar R-1 School District staff regarding Bob Holmes; **ATTACHED.**
- 3.) Any school policies related to the promotion of religion in Bolivar R-1 School District, including by outside visitors; **please find the policies of the District at: https://simbli.eboardsolutions.com/SB_ePolicy/SB_PolicyOverview.aspx?S=380&Sch=380**
- 4.) Any financial records related to performances by Bob Holmes, including invoices, checks, and receipts. **ATTACHED.**

District personnel regret that, for a few moments, Mr. Holmes failed to confine his presentation at the assembly to the agreed upon topics of drug abuse, alcohol abuse and suicide prevention. I have been assured by the Superintendent that he will not be invited back for any future engagements. As I mentioned in my earlier letter, the District did not intentionally promote any improper religious speech at the school assembly in question and will continue to respect the Establishment Clause of the 1st Amendment as well as the current jurisprudence interpreting same. By this letter, we will consider this matter closed.


