Re: Religious Assembly in Public School

Dear Dr. Berry:

I am writing on behalf of the Freedom From Religion Foundation (FFRF) regarding a constitutional violation that occurred in the Bolivar R-1 School District. FFRF is a national nonprofit organization with over 32,000 members across the country, including nearly 400 members in Missouri. FFRF's purposes are to protect the constitutional separation between state and church, and to educate the public on matters relating to nontheism.

A concerned parent contacted us to report that Bolivar High School recently invited Bob Holmes, the "one man volleyball team," to give a presentation to the student body. It is our understanding that Mr. Holmes was accompanied by representatives of the Agape Baptist Church of Stockton, Missouri, who took pictures and video of the event. A post on the "Agape Baptist Church of Stockton Missouri" Facebook page from March 16, 2018 says: "the Lord allowed us [the Church] to get into Bolivar High School, Stockton High School, and Stockton Middle School through Bro. Holmes ministry to the public schools." This same post refers to him as "Evangelist Bob Holmes," "a friend of Agape for many years now."

We understand that the BHS assembly was held in the school gymnasium on February 20, 2018 from 10:30am to 11:30am, during regular instructional hours. It is our understanding that during this assembly, which was ostensibly about bullying and suicide prevention, Mr. Holmes took several opportunities to preach his Christian faith to the captive student audience, proclaiming that "Jesus Christ is my lord and savior, and I'm not ashamed to tell you that." He also recounted a story of a troubled teenager who turned her life around after accepting Jesus as her savior:

"Another girl was molested in thirteen foster homes. And because she got forgiven by the lord Jesus, she went to every one of her child molesters and said, 'I forgive you because I got forgiven by my wonderful savior.'"

At the end of the assembly, Mr. Holmes invited everyone to hear "part two" of his message the following Thursday night at Stockton High School, telling the students "you're going to hear something you won't believe—it's unbelievable what I'm going to say... Don't miss it." The event at Stockton High School was also advertised through flyers posted on the walls of

the Bolivar High School. The same flyer was also posted on the Agape Baptist Church Facebook page on February 16, 2018.

Neither Mr. Holmes' announcement, nor the flyers mentioned that the Stockton High School event was a full-scale Christian revival, once again in cooperation with Agape Baptist Church. During the Stockton High School event, Mr. Holmes preached a sermon that recounted the crucifixion of Jesus in explicit, gruesome detail. He also aggressively proselytized the students, telling them that they "have a soul that's going to go on forever, and ever, and ever, either in heaven or hell. And I see you hanging over a lake of fire ready to fall in unless you find forgiveness." He closed by asking the audience to bow their heads in prayer and receive Jesus as their savior.<sup>1</sup> The Agape Baptist Church Facebook page declared: "The Lord used Bro. Holmes in a great way and as a result, 81 people left the evening rally having accepted Christ as Lord and savior."

At both the BHS assembly and the Stockton event, Mr. Holmes declared his intention to bring his message to every public school in Missouri. At Stockton, he announced that "there are some people right now that are working" to make this happen, including **"the principal that I was at [sic] in Bolivar and here—all of them want to see this..."**

#### **The District failed to exercise due diligence.**

We are aware that many Christian missionaries insinuate themselves into public schools by camouflaging their purpose. However, in the case of Bob Holmes, it would only require a cursory Google search to verify his proselytizing agenda. His own website refers to his work as a "ministry"<sup>2</sup> and his official Facebook page is replete with references to his evangelism.<sup>3</sup> Please see the enclosed images.

Bob Holmes is not an entertainer, nor a motivational speaker: he is a missionary. In a news story from last year (a link to which is on Mr. Holmes' Facebook page), he said:

**"I'm so grateful for my church, Temple Baptist, because they're sending me out across the country to try bring hope to young people, and Jesus Christ is the only answer—of course, I know I have to be careful what I say in a school."**<sup>4</sup>

Mr. Holmes openly proclaims his intent is to convert other peoples' children to Christianity. In a sermon to his home church (posted on YouTube and publicly-viewable) he said:

**"Why do I go to 5,000 schools? Because I just love volleyball—can't wait to play again?[...] I don't do it for volleyball, I do it because I've got an absolute truth [holds up a bible] and I can save somebody."**<sup>5</sup>

Mr. Holmes' Facebook contains a link to an interview he did with "Jesus Nation TV" (once again, posted on YouTube and publicly-viewable) in which the interviewer says: "We need Jesus. We need Jesus all across this world, **but we need Jesus in our schools—and Bob Holmes is taking Jesus to our schools.**"<sup>6</sup> In a self-authored biography page on "youthpastor.com," Mr. Holmes openly discusses his "evangelism" in public schools.<sup>7</sup>

In short, there is an astonishing amount of publicly-available information, much of which comes from Mr. Holmes himself, showing that he is an unapologetic missionary. Considering this glut of information, coupled with Mr. Holmes' endorsement and accompaniment by members of Agape Baptist Church, we do not understand how this event could have been approved.

**The District violated the Establishment Clause by inviting Bob Holmes and promoting his event at Stockton High School.**

It is inappropriate to take away instructional time from students to expose them to a Christian missionary, regardless of any secular message the speaker claims to be promoting. It is well-settled that public schools may not advance or promote religion. *See generally, Lee v. Weisman*, 505 U.S. 577 (1992); *Wallace v. Jaffree*, 472 U.S. 38 (1985); *Epperson v. Ark.*, 393 U.S. 97 (1967); *Sch. Dist. of Abington Twp. v. Schempp*, 374 U.S. 203 (1963); *Engel v. Vitale*, 370 U.S. 421 (1962).

A child's religious or nonreligious upbringing is a personal matter between the child and their parents. *See Santa Fe Indep. Sch. Dist. v. Doe*, 530 U.S. 290, 310 (2000) ("the preservation and transmission of religious beliefs and worship is a responsibility and a choice committed to the private sphere." (quoting *Lee*, 505 U.S. at 589)). The Supreme Court has repeatedly held that public schools may not be co-opted, either by staff or outside adults, to proselytize students. *See, e.g., Edwards v. Aguillard*, 482 U.S. 578, 584 (1987) "[f]amilies entrust public schools with the education of their children, but condition their trust on the understanding that the classroom will not purposely be used to advance religious views that may conflict with the private beliefs of the student and his or her family."). *See also McCollum v Bd. of Ed.*, 333 U.S. 203, 210 (1948) (holding that the Constitution forbids the "utilization of the tax-established and tax-supported public school system to aid religious groups to spread their faith.").

Allowing a self-avowed evangelist and an accompanying cohort of church representatives even one-time access during school hours to preach and recruit students for religious events is a violation of the Establishment Clause. The courts have protected public school students from overreaching outsiders in similar situations. *See, e.g., Berger v. Rensselaer School District*, 982 F.2d 1160 (7th Cir. 1993) (holding that distribution of bibles by Gideons in school violated Establishment Clause). Accordingly, courts have granted injunctions against schools for their complacency in these matters. *See, e.g., Roark v. South Iron R-1 Sch. Dist.* 540 F. Supp.2d 1047, 1059 (E.D. Mo., 2008); *upheld in relevant part by 573 F.3d 556*, (8th Cir. 2009) (holding that school policy allowing evangelical Christian organization

to distribute bibles in school violated Establishment Clause). The violation in this case is only further exacerbated by the District's promotion of the rally at Stockton High School.

**Request for Public Records.**

In order to better understand why the District allowed an admitted evangelist into its schools, pursuant to the Missouri Sunshine Law, Chapter 610, Revised Statutes of Missouri, we request copies of the following records:

- 1.) Any contracts or agreements between Bolivar R-1 School District and Bob Holmes or any representative of Bob Holmes;
- 2.) Any records (including emails, brochures, letters, etc.) received or sent by Bolivar R-1 School District staff regarding Bob Holmes;
- 3.) Any school policies related to the promotion of religion in Bolivar R-1 School District, including by outside visitors;
- 4.) Any financial records related to performances by Bob Holmes, including invoices, checks, and receipts.

**Conclusion.**

We request that Bolivar R-1 School District refrain from sponsoring inappropriate and unconstitutional assemblies moving forward, and that the District ensures that assemblies from outside groups or speakers do not contain an underlying proselytizing message or agenda. **We request specific assurances that Bob Holmes will not be invited to speak at any District schools in the future.**

If your office does not maintain the requested records, please direct me to the proper custodian. Any records available in electronic format may be emailed to [colin@ffrf.org](mailto:colin@ffrf.org). Should you deny this request, please provide a written explanation, including references to any statutory exemptions upon which you rely. If I can provide any clarification that will expedite your attention to this request, please contact me at (608) 256-8900.

We request a reply in writing detailing the steps you are taking to remedy this violation.

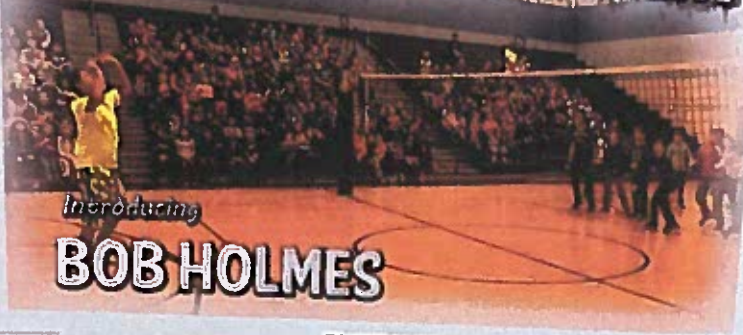
