Due to the large nature of the staging and production, the Todd Becker Foundation will arrive the night before the event and begin setting-up. The facility (gym/auditorium) will be occupied for the assembly and evening event approximately from Tuesday evening until approximately 12:00 AM on Wednesday night. Please inform all necessary classes typically meeting or using the gym/auditorium as well as the necessary custodial staff of this assembly and evening event.

I have received the sample "Opt-Out" letter informing parents of the assembly and I will review such letter to determine if it is necessary to send such letter home. In any case, the Todd Becker Foundation requests that the school have a simple, alternative activity for students who wish not to attend the assembly.

Scripture Quotation & Non-Proselytizing Agreement: MZ ◀ INITIAL HERE

No one acting on behalf of the Todd Becker Foundation will engage in religious proselytizing during the assembly presentation. The central theme of the assembly is making good life choices and the talk will include one Bible reference: Matthew 7:13: "The highway to destruction is wide and the road that leads to it is easy for the many who choose this way. But the gateway to life is small and the narrow road that leads to it is hard, but only a few ever choose this way." The Todd Becker Foundation agrees that the reference to this scripture will be done in a non-proselytizing manner.

Private conversations resulting from the assembly: MZ ◀ INITIAL HERE

Given the impactful nature of the assembly and the real-life tragedy involved, some students might want to talk with someone after the assembly in order to process issues going on in his or her life. Therefore, to help with this need, I agree to provide a reasonable time immediately after the assembly for impacted students to talk with a volunteer, teacher, school counselor or representative of the Todd Becker Foundation. It should be noted that such conversation(s) are completely voluntary and at the student's discretion. Although information, struggles or life-issues shared by the student during these private conversations are kept confidential, the Todd Becker Foundation will follow all mandatory reporting guidelines if a student's physical wellbeing or other students physical wellbeing is at risk (suicide, abuse, etc.) Furthermore, I understand that such conversations which involve a Todd Becker Foundation representative or volunteer will typically involve them referencing a helpful Bible passage and/or praying with or for the student only in the cases where the student freely consents to such Bible references or prayer. In no case will I restrict any member or representative of the Todd Becker Foundation from being available to talk with impacted students who need help processing issues going on in his or her life. In addition, all such conversations with students will take place in an open, visible and public area (typically the venue seating, i.e. gym bleachers or auditorium seats) and will not, under any circumstances, take place in a private area or room.

Outside influence on this assembly contract: MZ ◀ INITIAL HERE

An "Outside Influence" shall be any organization, group, club or individual not directly connected to, or officially associated with the school. I understand that the Todd Becker Foundation is a faith based, Christian organization that has a long standing reputation of presenting a positive and impactful assembly which is wholly appropriate for the public school setting. Having said this, I understand there are many outside individuals or organizations with a specific agenda to oppose any positive and/or faith based message in public schools. I understand that such outside groups or individuals may try to intimidate, threaten, harass and inhibit the execution of the details set forth in this contract. Therefore, I will not let any outside influence dictate or contribute to the changing or modification of the originally agreed to items in this contract, nor will I allow any outside influence to contribute to the cancellation of this assembly contract.

Cancellation or changes to this assembly contract: MZ ◀ INITIAL HERE

I understand that the cost of this assembly, which is \$6,215 is being underwritten and raised by local community churches, civic groups, youth groups as well as local businesses. Therefore, if the school chooses to cancel, modify or change this agreement for any reason other than a weather emergency or a school emergency (recent student tragedy, teacher strike, etc.) the school agrees to pay the Todd Becker Foundation the cost of the assembly, totaling \$6,215, due within 10 days of the originally scheduled assembly. In the case that such modifications or changes (change in time, facility, etc.) requested by the school are mutually agreed to by the Todd Becker Foundation, such payment due from the school shall be waived.

I have reviewed the above details and associated attachments regarding the assembly and night event and I verify that all information and items are correct and accurate. Therefore, I agree to adhere to the details set forth in this contract. The date for the assembly and night event will be kept as planned in this contract, except in the occurrence of a weather emergency, in which case the assembly and night event will be rescheduled within 10 months of the originally planned date. In any case, all finances submitted to the Todd Becker Foundation will be kept and applied towards a future assembly date.
