Re: District Entanglement with The Venue Church

Dear Mr. Julian:

I am writing on behalf of the Freedom From Religion Foundation (FFRF) to alert you to further constitutional violations occurring in Seminole County Public Schools.

We have received several reports of further illegal religious activity in your district, including a serious level of entanglement between The Venue Church and at least two schools in your district, Lake Brantley High School (LBHS) and South Seminole Middle School (SSMS). Each of these issues standing alone presents serious constitutional problems; in conjunction, they indicate a systemic lack of adherence to the strictures of the Establishment Clause in Seminole County Public Schools.

We will address these issues in turn. An open records request follows.

#### #1: Partnership with The Venue Church

It is our understanding that The Venue Church (the Church) has attempted to ingratiate itself with the district. We understand that the Church holds weekly services and other church events at LBHS and SSMS, and that the Church's goal is to "invest in students through interacting with the school to impact the community." It has no plans to invest in its own building. *See* Enclosure #1. "We are permanently planting churches in Central Florida Schools," the Church claims. Enclosure #2.

The Florida Supreme Court has held that it is impermissible for a church to permanently occupy a school with no intention to build its own building: "[I]f the use of the school building were permitted for prolonged periods of time, absent evidence of an immediate intention on the part of the Church to construct its own building, we think it could hardly be contemplated that the public school system or its property could be employed in the permanent promotion of any particular sect or denomination." *Southside Estates Baptist Church v. Bd. of Trustees*, 115 So. 2d 697, 700 (Fla. 1959).

Seminole County Public Schools must therefore sever its relationship with the Church, and going forward may not give special treatment to the Church and its administrators or promote the Church and its events.

#### #2: Administrator Endorsement

We understand that several District employees have publicly endorsed The Venue Church. School Board Chairperson Karen Almond and South Seminole Middle School Principal Mia Coleman-Baker both participated in a promotional video for the Church, using their official titles. Coleman-Baker in particular extended SSMS's support in no uncertain terms, speaking on behalf of the school and saying, "South Seminole Middle School is pleased to be able to offer our location, right in the heart of our community... We are excited to welcome The Venue to support our students and families." The video appears to have been shot on campus as well. The Church then posted a picture stating it was "grateful for the personal support of our Principal [and] our School Board Member." Enclosure #3. In addition, the Church published a note sent by Brian Shafer, Dean of Students at LBHS, to Pastor Brian Pikalow, in which he stated that "my prayer is for the Venue Church @ Lake Brantley to continue prospering and grow and reach the community for Jesus Christ." Enclosure #4.

Public school employees are government actors and subject to the strictures of the Establishment Clause's separation of state and church. To that end, "a school can direct a teacher to 'refrain from expressions of religious viewpoints in the classroom and like settings." *Helland v. South Bend Comm. Sch. Corp.*, 93 F.3d 327 (7th Cir. 1993) (quoting *Bishop v. Arnov*, 926 F.2d 1066, 1077 (11th Cir. 1991)). Many federal courts around the country have prohibited religious messages or conduct by teachers. *See, e.g. Johnson v. Poway Unified Sch. Dist.*, 658 F.3d 954 (9th Cir. 2011) (restricting teacher's display of religious posters in the classroom), *cert. denied*, 132 S.Ct. 1807 (2012); *Lee v. York*, 484 F.3d 687 (4th Cir. 2007) (upholding school district's removal of religious postings on classroom bulletin boards). The District should make certain that its employees do not unlawfully and inappropriately endorse religion by participating in the promotion of a church, particularly while on school grounds.

Public schools have a constitutional obligation to remain neutral toward religion. When school officials endorse a particular church and invite its involvement in the school, they have unconstitutionally entangled themselves with that church. It is also a usurpation of parental authority – parents have the right to direct the religious, or non-religious, upbringing of their children, not public schools. Such a practice alienates those non-Christian students, teachers, and members of the public whose religious beliefs are inconsistent with the message being promoted by the school. It is particularly inappropriate for the almost 20% of the U.S. population who identify as non-religious, including 32% of the population under 30.<sup>2</sup>

#### #3: Entanglement with Venue Pastors

The Church's pastors have apparently been given special access to the District's activities and employees. Pastor Andy Searles spoke to students at SSMS's "Teach In." Enclosure #5. The Church was permitted to have a table at SSMS's 50<sup>th</sup> Anniversary Celebration. Enclosure #6. Searles stated in a letter that he "had the opportunity to meet and pray with some of the Christian teachers on [the SSMS] campus this past Tuesday...This is going to become a regular part of my routine." Enclosure #7. Finally, Searles apparently serves on the Teacher of the Year Committee for the District. Enclosure #8.

Inviting the Church's staff to participate in District committees, letting the Church recruit at a school celebration, and permitting Church staff to come on campus to pray with staff is all highly inappropriate and further demonstrates the District's entanglement with and endorsement of the Church. Frequently allowing the Church this special access demonstrates the District's endorsement of not only religion over nonreligion, but also Christianity over all other faiths, and The Venue Church over all other denominations.

#### #4: Fellowship of Christian Athletes

Lake Brantley Fellowship of Christian Athletes (FCA) Twitter messages indicate that the formation of the club was announced at the first meeting of The Venue Church and LBHS, and that Pastor Brian Pikalow coordinates meetings of the executive officers. Enclosure #9 and #10. The Venue Church and FCA signs were posted together at an apparently coordinated "community give-back" event at LBHS. Enclosure #11.

The LBHS FCA clearly violates the federal Equal Access Act, which states that a school must "uniformly provide[]" that school clubs are "voluntary and student-initiated," and that "nonschool persons may not direct, conduct, control, or regularly attend activities of student groups." 20 U.S.C. § 4071(c)(1), (3), (5).

#### #5: Journey 365

We also understand that the District has promoted staff participation in the fitness program Journey 365 and its 50 Days of Fitness challenge, which was founded by Venue co-founder and pastor Todd Lamphere, and that the Church paid for some schools' staff members to do so. Enclosure #12. We also understand this program is religious. Its website states that it is a "national wellness initiative bringing premier health information and services through the local church to the surrounding community." Enclosure #13. One testimonial states: "This program not only changed my life physically, but more importantly spiritually. The amazing leaders I had made it a priority for me to grow in my faith and improve in my walk with Christ. Since 50 Days of Fitness, my walk with Christ has drastically changed and has continued to strengthen each and every day." Enclosure #14. In a video promoting the program to pastors, Pastor Lamphere states "People are spiritually sick, and the way that we're going to address their spiritual unhealthiness is by addressing their physical unhealthiness. And as we do that, we've earned the right to be able to share Jesus with them." In a video testimonial, one participant claims, "I believe a lot of

the difference for me in this program has been that there are people praying for me."<sup>4</sup> Others allude to daily bible devotionals in a journal provided by the program.

The District should not promote this program, which clearly proselytizes to its participants. Again, this demonstrates public endorsement of a Christian program, in violation of the Establishment Clause.

#### #6: Church Sign

We are also informed that Greater Life Church rents Lawton Chiles Elementary School and has permanently posted an advertisement on a fence at the school. Enclosure #15. It is inappropriate for the District to permit advertisement of religious organizations or churches on school property. A reasonable observer would view the Christian church's prominent, permanent advertisement located on public school grounds as District endorsement of that church's views. These advertisements should be removed or displayed only during the churches' actual rental time to avoid any further Establishment Clause concerns.

#### **#7: Team Chaplains**

Venue Pastor Todd Lamphere's biography states that he was previously the chaplain of the Lyman High School and Lake Howell High School football teams. Enclosure #16. If it is still the practice of any district schools to have team chaplains, the practice must end. It is inappropriate and unconstitutional for the district to offer a Christian minister unique access to befriend and proselytize student athletes. Accordingly, public high school athletic teams cannot appoint or employ a chaplain, seek out a spiritual leader for the team, or agree to have a volunteer team chaplain, because public schools may not advance or promote religion. Non-school persons cannot be allowed to treat the school as a recruiting ground for their religious mission.

#### Conclusion

All of these actions demonstrate that Seminole County Public Schools is endorsing religion. This "[s]chool sponsorship of religious message[s] is impermissible because it sends the ancillary message to...nonadherents 'that they are outsiders, not full members of the political community and accompanying message to adherents that they are insiders, favored members of the political community." *Santa Fe*, 530 U.S. at 309-10 (2001) (quoting *Lynch v. Donnelly*, 465 U.S. 668 (1984)) (O'Connor, J., concurring). These actions undeniably turn any non-believing or non-Christian student, teacher, staff member, or visitor into an outsider.

It is very clear that a religious atmosphere has been directed and cultivated in the school district. No doubt some of these problems arise because of the school's unconstitutional relationship with The Venue Church and its pastors. We intend to address that relationship and other issues further after our open records request has been fulfilled.

The allegations set forth above are violations of the Establishment Clause which the District must remedy immediately. Specifically, we require written assurances that the District is:

- 1) Severing all ties with The Venue Church, including the landlord-tenant relationship,
- 2) Ensuring that District employees do not provide official endorsements to The Venue Church or any other religious group,
- 3a) Ensuring that religious groups are not permitted to recruit at District events,
- 3b) Ensuring that The Venue Church pastors and other clergy members are not given special treatment to serve on District committees or to conduct religious activities with teachers on school grounds,
- 4) Ensuring the LBHS FCA and all other school clubs are truly student-initiated and student-run,
- 5) Ceasing all promotion of the Journey 365 program,
- 6) Removing the Greater Life Church sign at Lawton Chiles Elementary School, and any other similar signs at other schools,
- 7) Ending the position of Team Chaplain for all athletic teams, if it still exists, and
- 8) Holding district-wide training to ensure that "subsidized teachers do not inculcate religion." *Lemon v. Kurtzman*, 403 U.S. 602, 619 (1971).

It is not viewpoint discrimination to sever ties with the Church because of these violations. There is not simply a concern about state-church entanglement here, there are clear and consistent violations of the separation of church and state, and completely ending the relationship between the District and the Church should be the consequence of that entanglement.


