## CONSENT DECREE AND DISMISSAL WITH PREJUDICE

- Defendants will permanently maintain the anonymity of the Plaintiffs in accordance with the prior Order of this Court dated February 12, 2013,
   (Document 7, incorporated herein by reference.)
- 4. Plaintiffs hereby dismiss with prejudice, all pending claims and motions.
- 5. Each signatory to this Consent Decree warrants and represents that he or she has the authority to bind the parties for which such person acts and such person has executed this Agreement freely and without duress, after having consulted with the parties, their representatives, agents, attorneys or assigns.

The Court retains jurisdiction to enforce the terms and provisions of this
 Consent Decree.
