Sir:

Will follow up with more complete "EXUM Report" and AAR, but want to get the word to you quickly reference how the Fort Bragg Christian Rock the Fort Concert went today, I know you our out of the states:

CH Egert and I felt at least on the ground that the event went smoothly. No incidents observed or reported to me by our chaplains (probably at least 30 chaplains) on the field, to include our Catholic priests of which I greatly appreciated their support. Additionally, COL Sicinski, Garrison Commander debriefed with security team and MPs and stated in an earlier email to the Senior Commander, LTG Helmick..."Zero protest like issues either at the gates or on site."

Attendance estimate was 1000 for children concert and 3000 for adult concert in the evening. COL Arata, Fort Bragg Corps PAO comments to LTG Helmick, "All is still good from a media side. Been on field since this afternoon and at least from an audience perspective all seems very low key and orderly. Not a huge crowd at all. Two local T.V. stations present with PAO escort channel 11 and channel 14 and Fayetteville Observer Newspaper....seemed positive in terms of interview."

The bands and speakers stayed within the parameters that we gave them as directed by LTG Helmick, "in other words keep it low key...share encouraging music and a gospel message with no statements that are critical of other religions." Prayer was conducted discretely and kept low key and Family Life Chaplains were present for counseling if needed for more in-depth pastoral care. The folks that attended seemed to enjoy the music and a there seem to a great atmosphere of community and fellowship on the field.

Sir, I opened up the 1400 session and 1700 session with comments that focused on spiritual fitness and spiritual resiliency as a part of the comprehensive soldier fitness program and that the Rock the Fort event was only one venue among many where soldiers can renew and invigorate their faith. Additionally, I re-emphasized the event was totally voluntary in nature. And that we actively support and honor all faith groups at Fort Bragg.

Sir, I realize that you are out of town, but have been keeping CH Birch and CH Griffin informed every step the way with supporting documents, media releases, and interviews.

Chet and I will keep you informed of further updates, but we are pleased with at least how the event was conducted and the wonderful community building that we saw on the field today.



You were correct to use Daughtry example. This, like all the MWR events, comes down to money when we look at support to any event. Special events generate overtime and unforecasted expenditures. Due to budget constraints and funding levels we are required to be reimbursed for services rendered that are outside of standard police requirements. Below I have provided items that should be added to the MOI and a cost/personnel break down. Your budget manager would have to work with the Directorate of Emergency Services budget section for the proper money transfer codes.

Personnel and equipment expenditures.

- 30 x DACPs ISO of security of event for 12 hours = approx. \$23,400

(Standard planning rate to include use of GSA vehicles for a MP/DACP is \$65 an hour)

- 8 x VMS cost \$300 each a day to rent. This would require 2 days of rentals. \$4800 in total

- 4 x light sets cost \$100 each a day to rent. This would require 2 days of rentals. \$800 in total

- 2 x 15-pack vans to transport security comes to approx \$800.

- Total forecasted security cost is \$29,000 to provide support to

the event.

MOI bullet changes.

1. Will only need 15 BMM MPs instead of 30 because of the threat. The PMO sections and DACPs fill in the other requirements to come up to the 30 x personnel, but are still added in the personnel security price.
2. Also, if you do this at Pike's Field or the Stadium it would reduce the Security and BMM (blocking points) requirements because the areas are more contained. Additionally, what about the Fairgrounds?
3. Must add a coordination piece with Fort Bragg Fire. Fort Bragg Fire must conduct inspections and usually have an element present.
4. EMS must remain on site through the entire concert, this includes until all spectators have departed the venue.
5. A threat assessment is required through the Fort Bragg Security and Intel section because of the number of personnel attending.
6. Security prior to the day of the event was not factored into this assessment. BMM or your organization need to perform this function. The PMO can drive by as part of our normal patrols.

Dear Ms. Gaylor:

Thank you for your letter of September 21, 2010 indicating your concern with the Rock the Fort event that will occur on Fort Bragg, North Carolina on September 25, 2010. I appreciate these concerns and do not take them lightly when determining whether it would be appropriate to permit events such as this to occur on Fort Bragg.

When I decided to allow this event to occur on Fort Bragg, I did so based on my analysis of the very provisions that you cite in your letter. As you likely know, to determine that it would be permissible to provide logistical support to this event, I determined that the support would neither interfere with official duties nor detract from readiness; that it served a legitimate DoD public affairs interest, military training interest, or community relations interest; that the event was appropriate for association with DoD; that the event was of interest and benefit to the community or DoD; that we would be willing and able to provide the same support to comparable events sponsored by similar non-Federal entities; that the support was not barred by statute or regulation; and that admission to the event was free.

As you rightly assert that this event is tailored to the interests of a particular faith, I have taken steps to ensure that no Soldier in my command is pressured in any way to attend this event. This event will occur during an off-duty time for the majority of the Soldiers on this Installation, and they are free to attend the event if they so desire. No one in this command should feel pressured to attend.

It is a well settled issue of Constitutional Law that it is permissible for the military to have a Chaplain's Corps and for that Corps to offer events of a religious nature to Soldiers on Installations such as Fort Bragg. I simply have to ensure that the opportunities to do so are not tilted in any way to a particular faith, and that the opportunities open to one faith are open to all faiths. I believe that this Installation's support for the Rock the Fort event does not cross this line, and am willing to provide similar support to comparable events sponsored by similar non-Federal entities that address the needs of the Soldiers on this Installation.

Thank you again for your letter. I appreciate your efforts to ensure that the Soldiers of Fort Bragg enjoy the very rights that they fight and serve to defend.

3. Applicability. This MOI applies to all units/agencies identified at paragraph 5, below.
4. General. Fort Bragg Garrison Religious Support Office (RSO) will host a Fort Bragg/Fayetteville community-wide Christian Rock the Fort Concert at the Main Post Parade Field on 25 Sep 10. Food vendors and children's musical and gospel presentation begins at 1400; the adult musical and gospel presentation begins at 1700 and concludes at 2030. Rock the Fort Christian Concert will feature gifted musicians, speakers, and bands. Rock the Fort will share a clear presentation of the Christian Gospel. Attendees will have an opportunity to respond to the Gospel Evangelistic message, be encouraged by Fort Bragg Chaplains and trained counselors, and then be offered ongoing Biblical Spiritual Resiliency training at our military chapels and local churches. Expected concert attendance is 10,000. This event will proceed rain or shine; no alternate site is planned due to the expected size of attendance.
5. Responsibilities.
 - a. Religious Support Office (RSO).
 - (1) Primary responsibility for planning and officiating the event.
 - (2) Assign an action officer, Prayer Team Leader, Counseling and Follow-up Team Leader, Stage/Arrangement Team Leader, Advertisement/Communications Team Leader, Volunteer Team Leader, Church Relations Team Leader, Children Team Leader, Logistic Team Leader, and Escort Team Leader for the event.
 - (3) Provide lodging, on-site transportation and meals for guest artists/speakers.
 - (4) Provide portable latrines.

(2) Provide sound stage and sound technician.

(3) Conduct Counseling Training and provide specific event requirements for Billy Graham Evangelist Association.

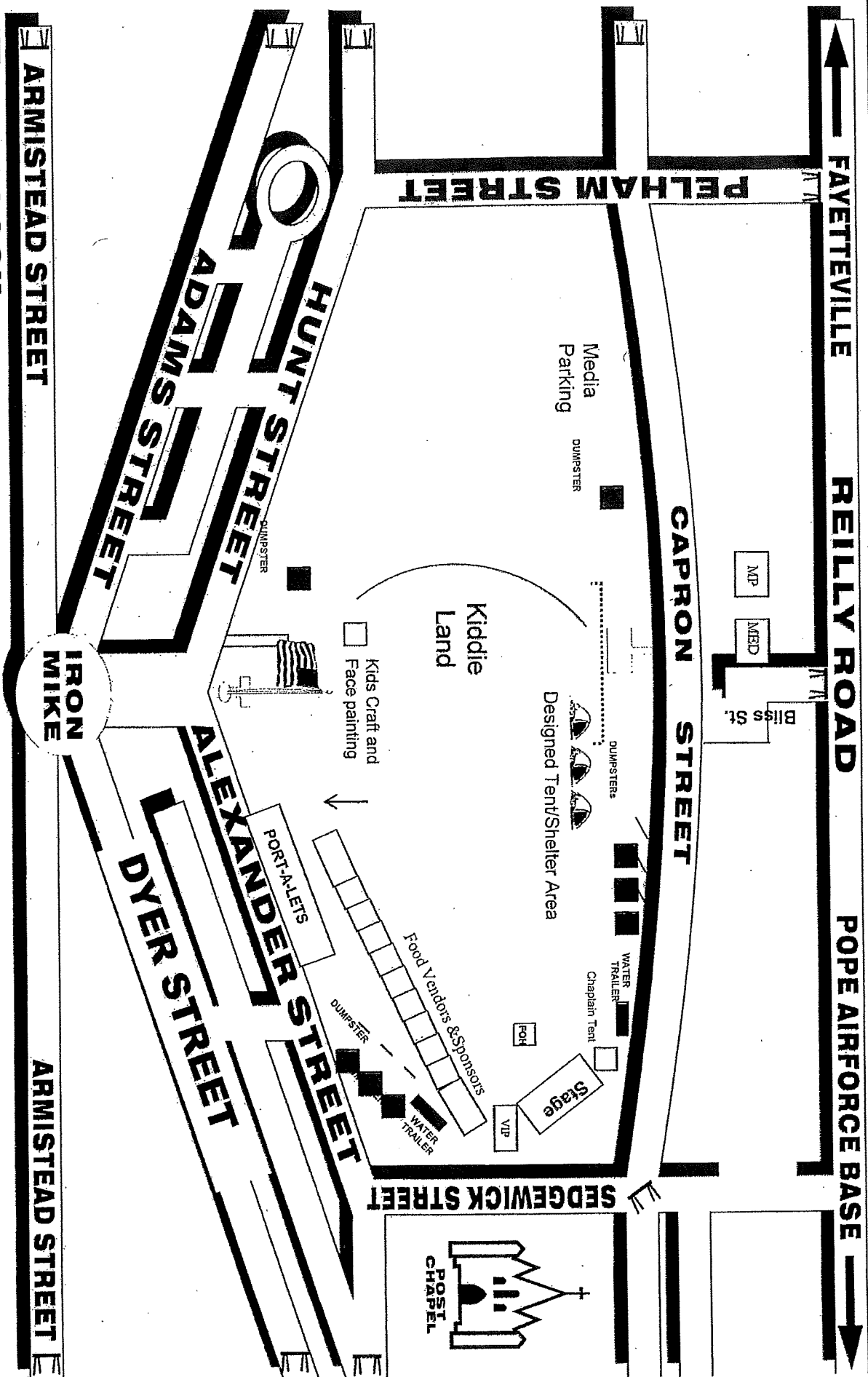

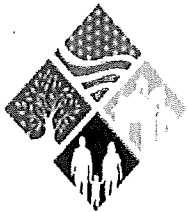

Parking

The hospital (WAMC) parking lot is reserved for all guests and can be reached via Reilly Rd and/or All American Hwy. Parking at the Fort Bragg Officer's Club, off Armistead St, is reserved for DOD Decal holders. Handicap parking is reserved adjacent to the Main Post Chapel located north of the Main Post Parade Field on Sedgwick Street. Alternate parking for the public will include parking areas east of Knox Street that which are not posted as restricted areas.

Restricted Areas

Restricted areas include posted areas reserved for VIPs or distinguished guests. Restricted areas also include any area that has construction signs or warnings. If your vehicle is parked in any of the restricted areas without authorization it will be towed.

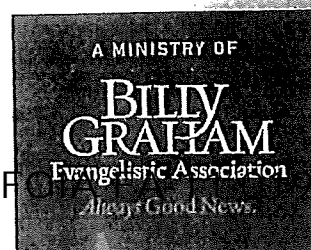

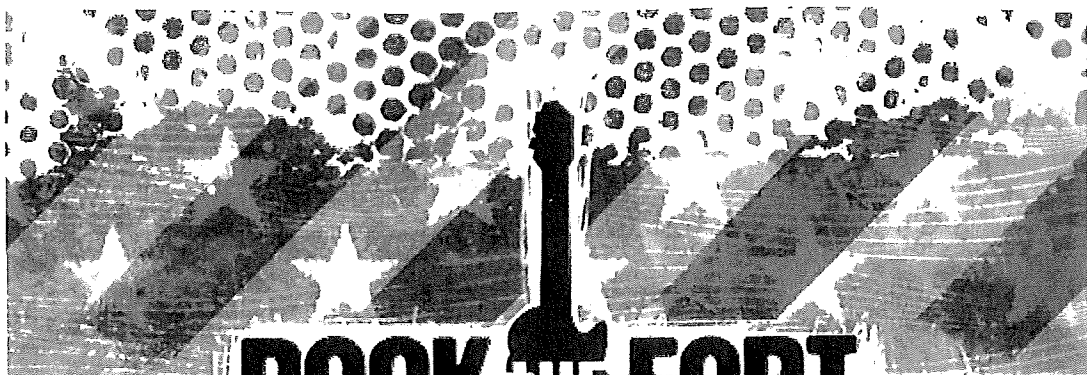

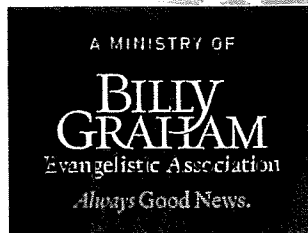

REGULATIONS THAT APPLY TO EVENT

AR 165-1

Section II

Responsibilities (additional responsibilities are found in subsequent chapters)

1-9. Commanders

The religious program for the Army is the commanders program. Commanders establish and maintain a climate of high moral and ethical standards. ~~Commanders will—~~

- a.* Provide equitable support for religious, spiritual, moral, and ethical activities of all personnel in their commands.
- b.* Provide opportunity, time, and facilities for the free exercise of religion in accordance with law, regulations, and mission requirements.
- c.* Accommodate special religious practices of personnel in their commands, consistent with DODD 1300.17 and AR 600-20.
- d.* Facilitate Chaplain access and support to commands or organizations without assigned Chaplains or unit ministry teams (UMTs) (see chap 3).
- e.* Approve and resource the CMRP.
- f.* Provide Chaplains, Chaplain Assistants, and Religious Education Specialists with the resources required for performing the religious support mission to include personnel, training, facilities, transportation, equipment, supplies, and financial resources (see chaps 12 through 15).
- g.* Approve use of government facilities for religious purposes (AR 210-22).
- h.* Support Chaplain-led programs that build and maintain strong personal character, Family structures, and moral well being (10 USC 1789) (see chap 16).

Joint Ethics 3-211. Logistical Support of Non-Federal Entity Events

a. The head of a DoD Component command or organization may provide DoD employees in their official capacities to express DoD policies as speakers, panel members or other participants, or, on a limited basis, the use of DoD facilities and equipment (and the services of DoD employees necessary to make proper use of the equipment), as logistical support of an event sponsored by a non-Federal entity, except for fundraising and membership drive events, when the head of the DoD command or organization determines all of the following:

(1) The support does not interfere with the performance of official duties and would in no way detract from readiness;

(2) DoD community relations with the immediate community and/or other legitimate DoD public affairs or military training interests are served by the support;

(3) It is appropriate to associate DoD, including the concerned Military Department, with the event;

(4) The event is of interest and benefit to the local civilian community, the DoD Component command or organization providing the support, or any other part of DoD;

(5) The DoD Component command or organization is able and willing to provide the same support to comparable events that meet the criteria of this subsection and are sponsored by other similar non-Federal entities;

(6) The use is not restricted by other statutes (see 10 U.S.C. 2012 (reference (f)) which limits support that is not based on customary community relations or public affairs activities) or regulations; and

(7) No admission fee (beyond what will cover the reasonable costs of sponsoring the event) is charged for the event, no admission fee (beyond what will cover the reasonable costs of sponsoring the event) is charged for the portion of the event supported by DoD, or DoD support to the event is incidental to the entire event in accordance with public affairs guidance.

b. The head of a DoD Component command or organization may provide, on a limited basis, the use of DoD facilities and equipment (and the services of DoD employees necessary to make proper use of the equipment), as logistical support of a

charitable fundraising event sponsored by a non-Federal entity when the head of the DoD Component command or organization determines (1) through (6) of subsection 3-211.a. of this Regulation, above, and the sponsoring non-Federal entity is not affiliated with the CFC (including local CFC) or, if affiliated with the CFC, the Director, OPM, or designee, has no objection to DoD support of the event. OPM has no objection to support of events that do not fundraise on the Federal Government workplace (which is determined by the head of the DoD Component command or organization.)

c. Speeches by DoD employees at events sponsored by non-Federal entities are not precluded when the speech expresses an official DoD position in a public forum in accordance with public affairs guidance.

d. Involvement of DoD resources in air shows sponsored by non-Federal entities is approved or disapproved by the Office of the Assistant Secretary of Defense (Public Affairs).

Religious support activities

Core competency: Professional Military Religious Leader. Core competency: Professional Military Religious Support Staff Advisor. Religious Services. Conduct worship, funeral, and memorial services.

Professional advice to the Commander and staff. 9. Moral and spiritual support Task 9.1. Conduct moral leadership training.

Task 9.2. Conduct spiritual development and sustainment

programs, such as Prayer Breakfasts and Spiritual Fitness events.

AR 600-20 • 18 March 2008

5-6. Accommodating religious practices

a. The Army places a high value on the rights of its Soldiers to observe tenets of their respective religious faiths. The Army will approve requests for accommodation of religious practices unless accommodation will have an adverse impact on unit readiness, individual readiness, unit cohesion, morale, discipline, safety, and/or health. As used in this regulation, these factors will be referred to individually and collectively as "military necessity" unless otherwise stated.

5-9. On-post distribution of nongovernment printed materials

a. Access to news and publications. The maintenance of loyalty, discipline, and morale among Soldiers is essential if the Army is to provide a reliable and effective military force responsive to the national security missions assigned pursuant to lawful authority. At the same time, Soldiers are generally entitled to free access to news and publications.

b. Policy. Installation commanders will encourage and promote the availability of books, periodicals, and other printed media that present a wide range of viewpoints on public issues to Soldiers. Such media should include those emphasizing the standards of loyalty, patriotism, and discipline that are common to the Armed Forces. However, installation commanders will not, except as provided in this paragraph and in AR 360-1, take action to control or restrict dissemination, even if these publications are believed to be in poor taste or unfairly critical of Government

policies or officials. The installation commander will be guided by the principle that, except in cases in which a publication constitutes a clear danger to military loyalty, discipline, or morale, or specifically violates the law or regulatory authority, military personnel are entitled to the same free access to publications as are other citizens.

AR 165-1

1-6. The Chaplaincy and the U.S. Constitution

a. The First Amendment to the U.S. Constitution prohibits enactment of any law “respecting an establishment of religion “or” prohibiting the free exercise thereof.” Congress recognizes the necessity of the Chaplain Corps in striking a balance between the establishment and free exercise clauses.

b. The Establishment Clause forbids any governmental authority from mandating a religion or way of prayer. In the pluralistic religious setting of the military, Unit Ministry Teams (UMTs) provide opportunities for religious support (worship services, religious classes, prayers, and so forth) for individuals from all religious backgrounds. Chaplains cooperate with each other without compromising their faith tradition or ecclesiastical endorsement requirements, to ensure the most comprehensive religious support opportunities possible within the unique military environment.

c. The Free Exercise clause guarantees individuals the right to practice what their religion requires and conscience dictates. Soldiers, Family members, and authorized Department of Defense (DOD) civilians are entitled to Chaplain support. Chaplains are expected to advise the command on all matters pertaining to the free exercise of religion and to speak with a candor and urgency befitting the exercise of their religious duties. Chaplains assist the commander in providing for the accommodation of religious practices.

d. The Chaplaincy is an instrumentality of the U.S. Government to ensure that the “free-exercise” rights of religion are not abridged. This constitutional principle is deeply imbedded in the statutory foundations of the Army. The Chaplain and Chaplain Assistant are core and essential manpower at every echelon of the force and are both inherently Governmental in Nature (GIN) – military (Memorandum, HQDA, DAMO-FMP, 30 October 2008, subject: Decision Point 91, Unit Ministry Team ((UMT) Implementation Plan). In maintaining the balance between the establishment and Free Exercise Clause, Army Chaplaincy functions are exempt from conversion to civilian structures.

1-7. The Chaplaincy and Public Law

a. Title 10, United States Code (USC), Section 3073 (10 USC 3073), Section 3547 (10 USC 3547), and Section 3581 (10 USC 3581), establishes the position of Chaplain in the Army and, together with regulations promulgated by the Secretary of the Army, prescribes the duties of that position. This statutory authority requires commanders to furnish facilities and transportation for Chaplains to perform their duty.

AR 165-1 • 3 December 2009 1

b. Public law requires Chaplains to conduct religious services for personnel of their assigned command.

c. The duties of Chaplains beyond those specifically mandated by statute are derived duties, assigned by the Army, with extensive historical and legal precedent. They are described throughout this regulation.

d. General Order No. 253, issued by the War Department, Washington, DC, dated 28 December 1909, established the position of Chaplain Assistant for the purpose of assisting the Chaplain in the performance of their official duties.

AR 165-1 15-3. Types of funds

- a. The Department of the Army Chief of Chaplains CTOF is managed directly by the OCCH and serves as a central depository for funds to supplement the APF religious program requirements Army-wide.
- b. Special organization CTOFs are established to give Chaplains serving units or organizations without a CTOF capability a flexible source of CTOF support to promote spiritual, moral, ethical, and related special activities in furthering the religious program of the Army.
- c. Installation CTOFs are established to support ongoing chapel programs and promote spiritual, moral, ethical, and related special activities in furthering the religious program of the military community.

15-7. Sub-accounts

a. Program Element (PE) sub-accounts—

- (1) Are subordinate congregational and activity accounts in the CTOF. The PEs are subject to available funds on deposit and are designed to implement stated CMRP objectives in support of the CMRP.
- (2) Are accounting entities and do not have an organizational existence apart from their inclusion in CTOF.
- (3) Cannot obligate/spend beyond their current sub-account balances.

b. The community sub-account—

- (1) Is a required sub-account of CTOF.
- (2) Is managed by the CTOF Manager.
- (3) Is reviewed and analyzed by the CPBAC.
- (4) Is funded by the transfer of a percentage calculated by the CTOF Manager through analysis of all regular offering (COA 100) income and the Installation community program requirements, as established by the Garrison Chaplain. Other sources of income may also be included as recommended by the CPBAC and approved by the Garrison Chaplain.
- (5) Provides a source of funds for programs that feature a community-wide focus or are sponsored jointly by multiple PEs.
