Re: National Day of Prayer Advertised in City of Warren Water Bills


Dear Attorney Biernat:

Our national organization, which works to protect the constitutional principle of separation between state and church, wrote to Mayor Fouts last year about the city of Warren's promotion of the National Day of Prayer event at City Hall. Please find enclosed a copy of that original letter. We never received a response. We write again because this issue has resurfaced as the National Day of Prayer draws near.

Once again, the City of Warren ("City") sent out a notice in city water bills, which publicizes this year's National Day of Prayer event. Our complainant informs us that this year's event is scheduled on May 5<sup>th</sup> from 12-12:45pm at Warren City Hall. Again, the notice does not list the official sponsor of the prayer breakfast. Please find enclosed a copy of the notice included in residents' water bills.

It is very troubling that the Mayor would choose to ignore our letter, which was sent on behalf of a local Warren resident. The constitutional concerns addressed in last year's letter have recurred with this year's upcoming event. Therefore, we ask for an immediate response in writing about the steps the Mayor's office is taking to address these serious concerns.

Re: National Day of Prayer Advertised in City of Warren Water Bills

Dear Mayor Fouts:

Our national organization, which works to protect the constitutional principle of separation between state and church, wrote to you recently regarding the constitutionality of National Day of Prayer events. We write again separately on behalf of a local Warren resident and taxpayer, who objects to the City's promotion of National Day of Prayer activities.

It is our information and understanding that recently the City of Warren ("City") sent out a notice in city water bills, which publicized this year's National Day of Prayer event. Our complainant informs us that this year's event is scheduled on May 6th from 12PM-12:45PM at Warren City Hall. The notice does not list the official sponsor of the prayer breakfast. Please find enclosed a copy of the notice included in residents' water bills. Our complainant informs us that this flier was included as an insert with the city's bill and has reason to believe that all Warren residents using City water services received this flier.

It is grossly inappropriate for the City to use its invoicing system as a mechanism for promoting the National Day of Prayer. The City cannot expend, even temporarily, government funds and resources to print and mail promotional materials for the National Day of Prayer event at City Hall. In order to comply with the law the City must discontinue the practice of expending any taxpayer dollars and public resources to promote the religious prayer event.

Any reasonable Warren resident would logically conclude that the City, and no other entity or private organization, is hosting the event. This also leads to the inevitable conclusion that the City, and you, as Mayor, favor religion over non-religion. Therefore, the City must take immediate action to disassociate itself from this religious event, which inevitably becomes an exclusively Christian event. Any promotional materials failing to indicate who the actual sponsor of the event is, or failing to provide an adequate disclaimer notifying the public that the City is not sponsoring, hosting or endorsing this particular religious event, must be taken down immediately to avoid further confusion.

We would appreciate a response in writing about the steps you are taking to end this violation.

## Grass Height City Ordinance (6 inches) goes into effect May 1!

### WARREN BEGINS THIRD SEASON OF 'NEIGHBORHOOD CLEAN SWEEP'

Warren is beginning its third season of "Neighborhood Clean Sweep," a neighborhood-by-neighborhood, street-by-street, house-by-house cleanup program by city inspectors.

The first section scheduled for clean-up is 8 Mile Rd. to 9 Mile Rd. and from Van Dyke to Hoover April 19-23.

Warren Mayor Jim Fouts, who initiated the program, said city inspectors from the city's property maintenance, building, DPW and sanitation departments will issue 5-day warning notices to commercial, industrial and residential property owners who have violated the city's property maintenance code.

"In 2008, we began the first sweep in Warren's 53-year history, and residents welcomed our inspectors," said Fouts. "The vast majority of residents comply after receiving a warning notice, so we only have to issue a small number of tickets."
